**Harmon Releases Audit of Magoffin County Clerk's Fee Account**

**FRANKFORT, Ky.** – State Auditor Mike Harmon today released the audit of the 2015 financial statement of Magoffin County Clerk Renee Arnett Shepherd. State law requires the auditor to conduct annual audits of county clerks and sheriffs.

Auditing standards require the auditor's letter to communicate whether the financial statement presents fairly the receipts, disbursements and excess fees of the Magoffin County Clerk in accordance with accounting principles generally accepted in the United States of America. The clerk's financial statement did not follow this format. However, the clerk's financial statement is fairly presented in conformity with the regulatory basis of accounting, which is an acceptable reporting methodology. This reporting methodology is followed for all 120 clerk audits in Kentucky.

As part of the audit process, the auditor must comment on noncompliance with laws, regulations, contracts, and grants. The auditor must also comment on material weaknesses involving the internal control over financial operations and reporting.

The audit contains the following comments:

**The county clerk's office lacks adequate segregation of duties:** The county clerk's office lacks adequate segregation of duties over the accounting and reporting functions of the clerk's office. This is a repeat finding and was included in the prior year audit report as Finding 2014-002. The county clerk is responsible for receiving cash, preparing daily deposits, preparing and signing checks, posting to receipts and disbursements ledgers, preparing monthly bank reconciliations, and also comparing the weekly, monthly, and quarterly reports to the ledgers.

A lack of segregation of duties increases the risk of undetected errors. The county clerk indicated this is a result of a limited budget, which restricts the number of employees the county clerk can hire or delegate duties to. A lack of segregation of incompatible duties or strong oversight

increases the risk of undetected errors. A proper segregation of duties over the accounting and reporting functions such as reconciling bank records to the receipts and disbursements ledgers or implementing compensating controls, when necessary because of a limited staff, is essential for providing protection from undetected errors. Additionally, a proper segregation of duties protects employees in the normal course of performing their daily responsibilities. The county clerk should separate the duties involved in receiving cash, preparing deposits, writing checks, posting to ledgers, preparing monthly bank reconciliations, and comparing financial reports to ledgers. If this is not feasible due to a limited budget, cross-checking procedures could be implemented and documented by the individual performing the procedure.

**The fourth quarter financial report was not complete and accurate:** The clerk's fourth quarter financial report did not agree to the clerk's receipts and disbursements ledger and reconciled bank balance. The clerk did not post all receipts and disbursements to the ledger, which resulted in inaccurate financial reporting. The clerk posted net payroll checks to the disbursements ledger and did not post retirement matching and social security matching to the ledger. Inaccurate financial records provide misleading information to the users of the information. Auditors compared the fourth quarter report to the disbursements ledger and discovered that disbursements per the fourth quarter report differed from the disbursements ledger by \$103,854. KRS 43.075(3) requires that "each person performing an audit shall whether the fiscal court or county official is complying with the requirements of the uniform system of accounts adopted under KRS 68.210, whether there is accurate recording of receipts by source and expenditures by payee[.]"

Auditors are responsible for determining the accuracy of the clerk's financial information, but are not responsible for correcting the clerk's financial information. In order to present the most accurate information possible to regulatory agencies, the fiscal court and the public, the clerk should implement procedures for ensuring the accuracy of financial information. Ledgers should be posted accurately and the fourth quarter report should agree to ledgers and the bank balance. Receipts and disbursements ledgers should be reconciled to the bank receipts and disbursements on a monthly basis. This would reduce reporting errors.

*County Clerk's Response: Oversight. Will correct in following years.*

The county clerk's responsibilities include collecting certain taxes, issuing licenses, maintaining county records and providing other services. The clerk's office is funded through statutory fees collected in conjunction with these duties.
